

Report of Corruption of the Middleton Police Department and the Dane County Court System

On April 14, 2001, at 12:41 pm, my wife Barbara was involved in a traffic accident at Park Street and Elmwood Avenue in the City of Middleton. The accident was caused by Gary L. Johnson (Transportation Supervisor for the Middleton-Cross Plains Area School District), who had lost control of his van, and had struck and damaged a third vehicle owned by Janet Lubcke. Even though Barbara's car was not involved in the accident at all, she was issued a falsified citation for "Failure to Yield Right of Way when Making a Left Turn" (Doc. 2894) by Police Officer Steven J. Britt, and Johnson was issued no citation.

On May 10, 2001, I appeared before the City of Middleton Municipal Court in Barbara's defense. I requested the court to dismiss the case and to return Barbara's bail payment (Doc. 2887). To my dismay, the arraignment procedure and pretrial conference was seriously flawed and illegal. Among the violations committed by Judge David H. Nispel, Court Clerk CC. Weide, and City Attorney Karl Kliminski include:

On May 16, 2001, I filed a Summons and Complaint in the Dane County Court for the unconstitutional arraignment and pretrial conference of Barbara J. Blaedel by Judge Nispel in the Middleton Municipal Court in his prosecution of Officer Britt's falsified accident report (Doc. 2893).

On July 2, 2001, I filed a Request for Summary Judgement with Judge Sumi due to improper and inadequate responses to my Summons and Complaint. In addition, I notified the court of my intentions to initiate future actions due to my failure to secure a restraining order against the Middleton Municipal Court, the intrusion of corporate attorneys into its court proceedings, and for offenses committed by the defendants' attorneys.

On July 20, 2001, Judge Sumi signed an Order of Dismissal of my lawsuit, without a hearing, in favor of the defendants.

On August 2, 2001, I filed a Notice to Appeal (Doc. 2913). In preparation for my appeal, I attempted to inspect the court record. Wayne Pfister, Jr. (Clerk of Court) obstructed and delayed my inspection, which caused me to request a Temporary Restraining Order against him (Doc. 2915).

On August 22, 2001, I again attempted to inspect the court records, which I obtained from Judith A. Coleman (Clerk of Court). To my dismay, four documents were withheld from the record in violation of Wis. Stat. § 946.72(1) (Tampering with public records). For their falsification of the court record (Doc. 2919), I submitted a notice of intent to sue Pfister and Coleman.

On September 26, 2001, I filed a Summons and Complaint against Pfister and Coleman for the withholding and falsification of court records (Doc. 2922). Further violations by Attorney John Moore, Deputy Clerk J. L. Hahn, Attorney Francis X. Sullivan, and Judge Robert A. DeChambeau resulted in my filing a Request for a New Judge and Request for Summary Judgement on December 28, 2001 (Doc. 2938). My report was ignored.

In summary, what began with the issuance of a falsified citation by the Middleton Police escalated into numerous violations committed by the Middleton Municipal Court, the Dane County Court system, attorneys, and numerous other court officials. For further details, please examine the documents related to the cases, as outlined below.
